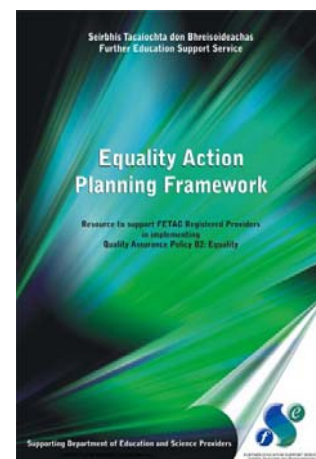

The Further Education Support Service Communications Resource - **Communicating in a Further Education Context**

has been developed by a FESS Task Group, comprised of several stakeholder representatives, to assist Providers / Centres in ensuring the effective implementation of Communications Processes and Procedures across all of the areas of the Provider's Quality Assurance Agreement with FETAC.

There are four main sections in the resource. These sections comprise tools that are designed to be used together or as independent instruments to assist Providers in

communicating with all stakeholders.

Section 1: FESS Communications Audit and Planning Tool

This will assist Providers in reviewing current communications practices across the QA areas with all stakeholders and in planning for the future.

Section 2: FESS Checklist for Providing Information to Learners

This will assist Providers in ensuring that all relevant information is communicated to Learners.

Section 3: FESS Checklist for Providing Information to Learners

This will assist Providers in ensuring that Staff are

informed of and updated with all relevant information.

Section 4: Suggested Methodologies for Communicating in a Further Education Context

This gives an overview of some possible communications methodologies that Providers may use.

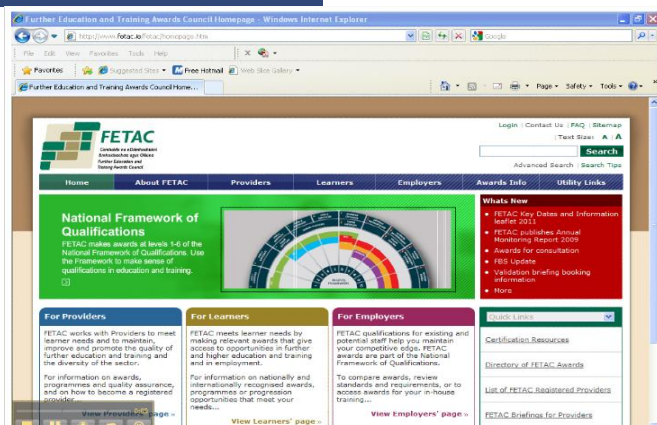
FETAC Awards for Consultation
